

**2022 Tomahawk Regatta
Lake Hopactong Yacht Club
June 4-5, 2022**

NOTICE OF RACE

1. AUTHORITY

- 1.1 The Organizing Authority is the Lake Hopatcong Yacht Club in conjunction with the International Star Class Yacht Racing Association hosted by the Lake Hopatcong Star Fleet.

2. RULES

- 2.1 The Regatta will be governed by the rules as defined in the current Racing Rules of Sailing (RSS) and the International Star Class Yacht Racing Association Rules (STCR).
2.2 Rule 35 and STCR 34.3.7, Format B, will be changed. The time limit for the first boat to finish a race will be two (2) hours.
2.3 Rule 35 and STCR 34.6.3 will be changed. Boats not finishing within 30 minutes after the first boat to finish will be scored Did Not Finish (DNF) and will be awarded 1 point more than the last boat to finish.
2.4 A boat that does not start within 10 minutes of the starting signal will be scored Did Not Start (DNS) without a hearing.

3. ELIGIBILITY AND ENTRY

- 3.1 The Regatta shall be open.

4. ENTRY FEE

- 4.1 The entry fee of \$100 includes boat and trailer storage, launching, hauling and breakfast and lunch on Saturday and Sunday at Lake Hopatcong Yacht Club for skipper and crew. Entry fees are due at time of entry.

Saturday June 4 0900 Skippers Meeting

1000 First Warning Signal

Up to 2 races may be sailed

1300 Saturday afternoon Halsey Island Race in honor of Bill Nutzel

Followed by Celebration of Life

Sunday June 5 1000 First Warning Signal

Series is scheduled for 4 races with no throwouts.

Up to 2 races will be sailed Sunday.

No warning signal after 1300 on June 5.

6. SAILING INSTRUCTIONS

- 6.1 The sailing instructions will be available at the Lake Hopatcong Yacht Club prior to June 4.

7. VENUE & COURSE

- 7.1 Racing will be conducted on Lake Hopatcong.
7.2 Courses will be as described in the Sailing Instructions.

8. DISCLAIMER

- 8.1 The organizing authority shall require each competitor to sign a waiver for loss, damage or injury to persons or property occurring in conjunction with the regatta or on the property at Lake Hopatcong Yacht Club.
