NOTICE OF RACE

1. Rules

The Regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* (RRS) and the rules of the International Star Class Yacht Racing Association (STCR). The Organizing Authority is Lake Sunapee YC The host fleet is Sunapee

- 1.1 Decisions of the Protest Committee will be final in accordance with RRS 70.5.
- 1.2 RRS
- 1.3 The prescriptions of US Sailing, shall apply.
- 1.4 RRS 32 will be changed to provide that courses will not be shortened.
- 1.5 RRS 33b will not apply.
- 1.6 RRS 35 will be changed to provide that boats not finishing within 60 minutes after the first boat to finish will be scored "Did Not Finish" without a hearing.
- 1.7 RRS 62.2 and 66 will be changed to shorten the time for requesting redress and the requesting that a hearing be re-opened on the last day of racing.
- 1.8 RRS A4.1 will be changed to provide that a boat failing to check in prior to the warning signal will be scored the same as a boat not starting in that race without a hearing.

2. Advertising

Boats may be required to display Event Advertising on the forward part of the hull. Out of respect to our title sponsor, advertising for liquor and for tobacco products is strongly discouraged.

3. Eligibility and Entry

- 3.4 For the purpose of RRS A Scoring: A competitor is not considered an entry until all fees are paid.

4. Fees

The entry fee of \$135 includes boat and trailer parking, launching, hauling and invitations to social events Aug. 4 -5 - 6 for skipper and crew. Entry fees are due on or before July 31, 2017. Guest \$45

7. **Sailing Instructions**
The Sailing Instructions will be available at registration.
8. **Venue**
Racing will be conducted on Lake Sunapee.
9. **Courses**
Courses will be according to STCR 34.
10. **Scoring**
The Low Point Scoring System, RRS A, will apply, modified so that each series score will be the total of her races scores with her worst score excluded if more than four (4) races are completed.
11. **Berthing**
Boats shall be at Lake Sunapee
12. **Haul-out Restrictions**
The Organizing Authority may impose haul-out restrictions.
13. **Team and Private Support Boats**
14. **Prizes**
- 14.1 Perpetual Trophies will be awarded
- 14.2 Series prizes will be awarded to the skipper and crew finishing first through third.
- 14.3 Master's trophy will be awarded to the skipper and crew for skippers aged 50 through 59 before the start of the first race, Grand Masters age 60 through 69, Exalted Master 70 + Competitors in the Master's Division's will also compete for Series prizes.

- 14.5 Daily prizes will be awarded to the skipper and crew finishing first through third in each race. Also some Special awards.
